Message from the Home Secretary regarding Membership Renewals

Each year I start sending out the renewal forms in Oct with a deadline of Dec 31st. From Oct to Dec and even into Jan/Feb, I send MANY email reminders. They go unnoticed or ignored, until of course there's a new puppy or dog in the family that needs training or they've realized I meant it that they would longer receive the newsletters.

This is from the Constitution and By Laws:

Dues: Membership dues shall be \$10.00 per year for individuals, \$5.00 per year for each additional person over eighteen in the same residence and/or \$5.00 for each junior member not to exceed \$20.00 per household. **Dues are payable on or before the first day of January of each year.** Each member of a household age 18 years or older will receive one vote. No member may vote whose dues are not paid for the current year.

Any member whose dues remain unpaid on the last day of March shall have their membership terminated without notice and shall forfeit to the Club all claims or benefits to which he/she may have been entitled.

A membership so terminated may be reinstated by the Board at any time within one year upon payment of the full current year's dues.

(II) After expiration of one year, reinstatement may be made only by application as prescribed for new members.

If you wish to continue the benefits the club offers, PLEASE follow the Constitution & By Laws.
