




Sportsmanship Award Goes to......

Training Class Changes

If you've looked at the webpage lately you may have noticed that we have changed a few things with our training classes, in hopes of creating a better flow.

So Tuesday's classes are ALL competition classes. Classes to prepare you for competition, beyond CGC. Wednesday's class are ALL the obedience classes, Puppy, Beginning and Intermediate ONLY. Rally class has moved to Tuesday's. Also for the Tuesday's classes, most will require a CGC in order to take a class. It is listed next to each class if it is a requirement. I have given the Tuesday & Wednesday class line ups below.

Wednesday night classes

- Puppy Obedience/good manners class dogs ages 10 weeks to 5 months
- Beginning Obedience/good manners class dogs ages 5 months and up.
- Intermediate Obedience class the next step after Puppy or Beginning class

All of these classes are an 8 week course.

Tuesday night classes – Most Tuesday night classes **REQUIRE** your dog to have a CGC (Canine Good Citizen) title in order to participate.

- Rally Obedience class (CGC Required) 7:00 pm work towards rally titles
- Agility class (CGC Required) 7:00 pm This class is only held May to September.
- Advanced Obedience (CGC Required) 7:00 pm Continue on with your obedience training and earn the CGCA (Canine Good Citizen Advanced) title.
- Competition Obedience (CGC Required) 7:00 pm 8:00 pm work towards the BN title and other Obedience titles.
- Tricks (CGC Required) 7:45 pm Earn all levels of Trick titles and build an everlasting bond with your dog.
- Beginning Scent Work (CGC Required) 7:45 pm prepare to earn Scent Work titles and be amazed at what a dogs nose can do!!
- Advanced Scent Work (CGC Required) 8:30 pm
- Conformation Handling −8:00 pm −8:30 pm Conformation Held as a 4 week class (**February**, **April**, **May**, **August**, **October**) cost of class is \$40.00 for the 4 weeks
- Temperament Test Introduction Held as a 4 week class (January, March, June, July, September) cost of class is \$40.00 for the 4 weeks

Embarking on a Journey Chapter 3 Tracking Seminar in Spokane, WA

November brought me another step closer to completing the requirements of my journey. A Tracking Seminar hosted by the Spokane Dog Training Club of Spokane, WA on November 16th. As it is just a one day seminar and an 11 hour drive I



choose to fly. I was able to get a non stop from here to Spokane, but unfortunately the last non stop for the return was much to early, so I needed to look for connecting flights that didn't have me sitting in Seattle for several hours. So I opted for a one carrier going out and another coming back. And again, another packing dilemma! This time not what to pack, but what to pack in. It's just an overnight trip, didn't need boots or any tracking equipment. Just needed a small bag. Thankfully my husband had the perfect size bag to fit all I needed and it would fit under the seat in front of me.

Arrived in Spokane about 4 pm, cloudy, rainy, yeah seems everywhere I go there is rain. But again not a hard rain, just sprinkles. I get the car and drive to the hotel, it's dark already, decide to stop to grab food, then check in. Waiting in the drive through at Burger King, I start looking around, seeing the folks walking around, the car in front of me and think, oh this looks pretty sketchy. Get my food, drive through the parking lot of Burger King and a church to the hotel. See the folks wandering around outside and just think let me get inside and the rental car be safe. Thankfully I parked in the right place and could look out the hotel window to check on the car every so often. This is one of the hotels that the club suggested and it is just 4 minutes from the clubs training building where the sem-

inar will be held. What the heck!

Morning came, looked outside, still dark, but I can see rental car is still parked where I left it. Yay! Still looks wet out, but no rain falling. I get ready for the day and pack up my little bag, then of course google Starbucks near me. Huh right across the street! Drove over there, by this time it is getting light, still cloudy, no rain and the area looks completely different in the morning than at night! Not so sketchy looking, actually really nice. Drive over to the clubs training building, get signed in and settled. Francis Keays, Tannis Whitherspoon and Judy Stomquist where there and ones I knew. Francis is the one who contacted me about laying track for the Idaho test, so we were able to talk about that. They had spaces for 4 TD, entries closed with 3 and she will give me 2 tracks to lay. Track 1 & track 3. Hmm, not sure how logistically that will work out, as normally the 1st 3 tracks are laid in 15 – 20 minute intervals. However the tracking regulations do say a TD/TDU track must be at least 30 minutes and no more than 2 hours aged. So we will deal with that come next weekend.







The seminar was presented by Carol Ruthenberg who is the AKC Tracking Field Rep. I meet Carol at the Wisconsin Tracking test back in June as she was testing a person to become a provisional judge. She got right down to business as the seminar use to be a 2 day event, but they have cut it to one day and she needed to get through a lot of information. I found myself listening more intently then I did the last time I attended a tracking seminar put on by our own club approximately 6 or so years ago. The information was vast and questions from the floor were many and great questions. There were about 30 people in attendance with approximately 10 to 12 being regular status judges, the remaining either on the same journey as myself or already provisional with a handful of exhibitors wanting to learn more about this sport they chose to jump into.

I had written Tannis earlier in the week and mentioned that I had a flight leaving at 5:20, so I would need to leave by 4. She said that would be fine as they were going to try to end by 4. At 3:30 Francis

leaves for the airport, I look outside and it is getting dark already! Come 4 I start getting a bit nervous as they still hadn't wrapped up, so I say goodbye to Tannis and head out. GPS says 28 minutes to airport, wow, I didn't even

stop to fill the rental, besides, what had I used, 2 gallons? Anyway make my way to the rental return, that takes 15 minutes, it is now 5:05, so head inside to head to my terminal and gate. Security was a breeze to get through as no one was there, but boy oh boy, had I known it was a mile from car return to gate I would have left the same time as Francis. Finally get to the gate and most had already boarded. Phew, that means I made it! And yes when I left the seminar at 4 it was almost dark! Needless to say the flight to Seattle went off like clockwork and the connecting flight too. I enjoyed the seminar and recommend anyone who has more interest in tracking with your dog, or becoming a judge, or just want to know some of the ins and outs to attend one. But the true lessons come from getting out there and being a tracklayer, or part of the tracking committee putting on a test. It takes a lot of logistics, hard work and support from many members.



Embarking on a Journey Chapter 4 Making Tracks in Idaho

There were only 3 and since I was track layer for 2 of them, they plotted all 3 in the same area so there wouldn't need to be to much driving around. I was trackerlayer for



Track 1 and track 3. I was told track 1 should be put down at 7:30 am, track 2 at 7:45 and track 3 when track 2 team starts unless instructed earlier. We got all 3 plotted, mapped and rewalked in quick order. I ran back to hotel to change and then headed to Francis' as she had invited me to dinner with her and Roy and to look at their maps. Map drawing hasn't been my best skill, but surprisingly when I looked at theirs to mine, all 3 were very close. So maybe there is hope for me yet. Had some good discussions on judging, testing and different things. Finally about 7, I needed to get going, so I headed back to the hotel. Once there, I went through my maps one more time, envisioned

each track and landmarks. I think I'm ready. Set the alarm, fell into a peaceful sleep.





Test day! Wow it is DARK out here at 6:45 am (yeah arrived a little too early, but better early than late) thankfully the snowmaking folks had lights on the grounds where they were making snow. Soon the tracklayer for track 2 arrived and we headed out to our designated spot to wait for the time to lay our tracks. I laid mine, Annie laid hers, now we just wait for the judges and exhibitors. They arrived at our spot about 8:10 and the 1st exhibitor is getting her dog, a little Wirehair Dachshund ready. Once they are ready and heading down the trail, I get out and follow. This little dog was gung ho and I had high hopes she would pass. But unfortunately she took went about 10 feet past the corner and




turned, and made it all the way to the fence line missing the glove completely. I went to lay track 3 while track 2 was getting started, but did get to see a part of it. Unfortunately they did not pass. Once track 3 was aged the team

It must have taken him 3 minutes to just get past the 2nd flag, and then it hit him...he knew why he was there and what he needed to do. Put his head down and he was all business, did the head swing at the cor-



ners, but wanted to be sure so circled and headed in the right direction all the way to the glove. This earns this little Beagle his TD2 title. What a fun little dog! Back at homebase, they did the award, had food out and waited for the time to do the draw for the TDX tracks. I wasn't able to stay to watch the TDX's as I h ad to get to the airport. I did hear later that there were no TDX passes. I give kudos to the Idaho Capital City Kennel Club.

They put on a nice test and the grounds are beautiful. The members and non members (yep, you read that






pletes my track laying requirements, and my seminar is completed. Now to find some plac-
