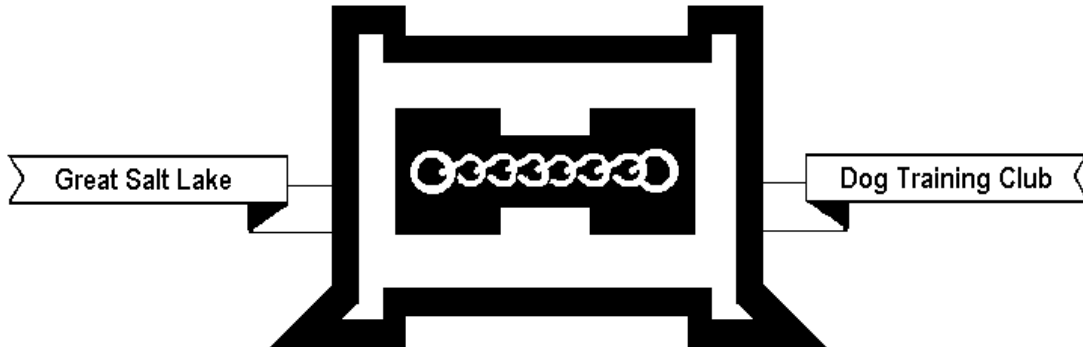

### **SARS-Covid 19 Precautions**

- ~ Masks are required at all times. Anyone not wearing a mask will be asked to leave.
- ~ Always maintain a 6 foot distance from anyone not living within your household.

### **DOG ELIGIBILITY**

Dogs who are at least 1 year of age are eligible to take the ATT and must either be AKC or FSS registered or listed with Canine Partners or have a Purebred Alternative Listing number. Dogs that are spayed or neutered may participate. Dogs must be able to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), in order to be eligible to earn an ATT title. Dogs with disabilities such as those that are blind, deaf, or have three legs are eligible to enter provided in the opinion of the evaluator they display no signs of physical discomfort and can safely complete the test. However, if a dog has multiple disabilities such that it is unable to complete whole categories of the test (i.e. auditory/visual stimuli), the dog would not earn the ATT title.

### **Other Reminders**

These tests will be held outside. Weather can be either warm or cold at that time of the year. Please dress accordingly. Please be prepared to wait in your car until your test(s).
