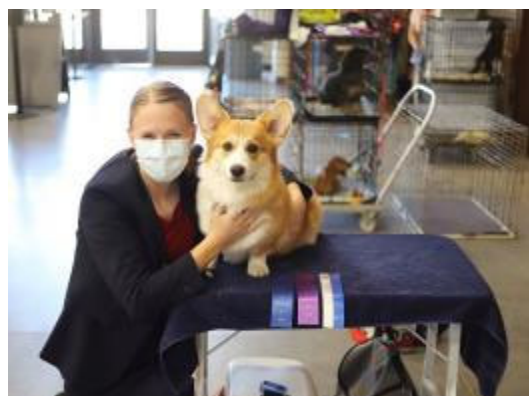






## Member's Page

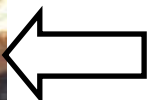

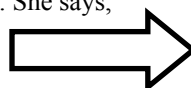

**From: Sheryl Hohle:** Go Zeta Potato! Leg #2 for her Excellent Standard title is in the books. She says, quit waking me up!





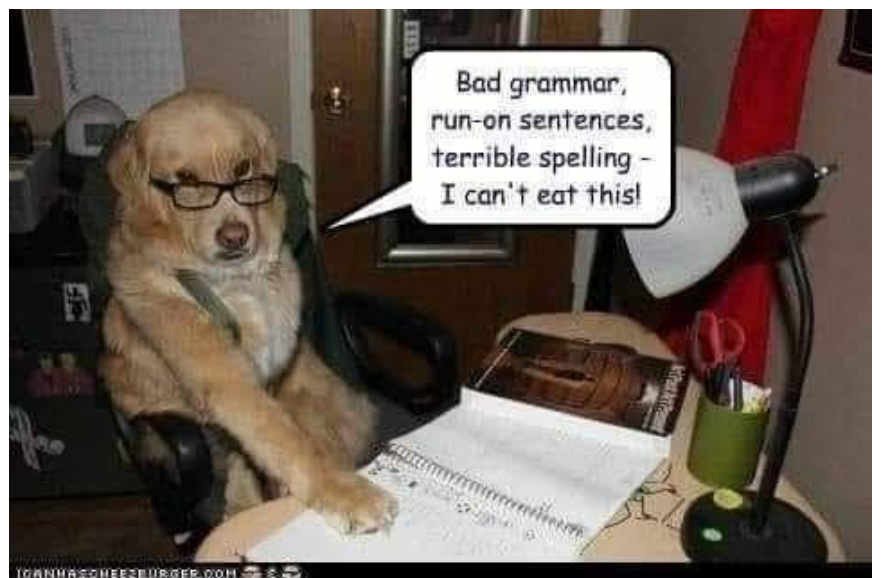
